

## PRIZE DRAW TERMS AND CONDITIONS

### 1. GENERAL

- 1.1 We are Evelyn Partners Services Limited registered in England and Wales at 45 Gresham Street, London EC2V 7BG, company no. 5169111, authorised and regulated by the Financial Conduct Authority. In these terms and conditions ("T&C") we are referred to as "we", "us", "Promotor" or "our".
- 1.2 These T&C govern the Prize Draw (as defined in clause 3).
- 1.3 Participation in the Prize Draw constitutes acceptance of these T&C. By entering the Prize Draw all entrants will be deemed to be bound by the T&C.

### 2. ENTRY REQUIREMENTS

- 2.1 The Prize Draw is open to all UK schools, entrants must be UK residents aged 18 years or over.
- 2.2 The Prize Draw is free to enter and no purchase is necessary.
- 2.3 All entries must be submitted via <https://www.evelyn.com/> and only one entry per school is permitted.
- 2.4 The opening date for entries is 09:00am on 19<sup>th</sup> March 2025. The closing date of the prize draw is 23:59 on 23<sup>rd</sup> April 2025. Entries received after this time will not be considered.
- 2.5 The Promotor accepts no responsibility for entries not successfully completed due to a technical fault or any kind.

### 3. PRIZE DRAW

- 3.1 A winner will be chosen by random draw on 30<sup>th</sup> April 2025.
- 3.2 The winner will receive a half day creative session facilitated by the Royal Academy (the "Prize Draw").
- 3.3 The winner will be notified by email or telephone (using details provided at entry) before 20<sup>th</sup> May. If a winner does not respond to the Promotor within 30 days of being notified by the Promotor, then the winner's prize will be forfeited and the Promotor reserves the right to offer the prize to the next eligible.
- 3.4 The prize for the winner is non-exchangeable, non-transferable and no cash alternative is offered.
- 3.5 The prize is supplied by The Royal Academy, Burlington House, Piccadilly, London, W1J 0BD United Kingdom. The Promotor reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond the Promotor's control makes it necessary to do so.
- 3.6 The decision of the Promotor regarding any aspect of the Prize Draw is final and binding and no correspondence will be entered into about it.
- 3.7 The Promotor must either publish or make available information that indicates that a valid award took place. To comply with this obligation the Promotor will publish the name of the winning school on its website on 20<sup>th</sup> May 2025. - 4.2 Insofar as is permitted by law, the Promotor will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the prize except where it is caused by the negligence of the Promotor.
