Waystone Management Company (IE) Limited is the UCITS Management Company of the ICAV (the "Management Company").

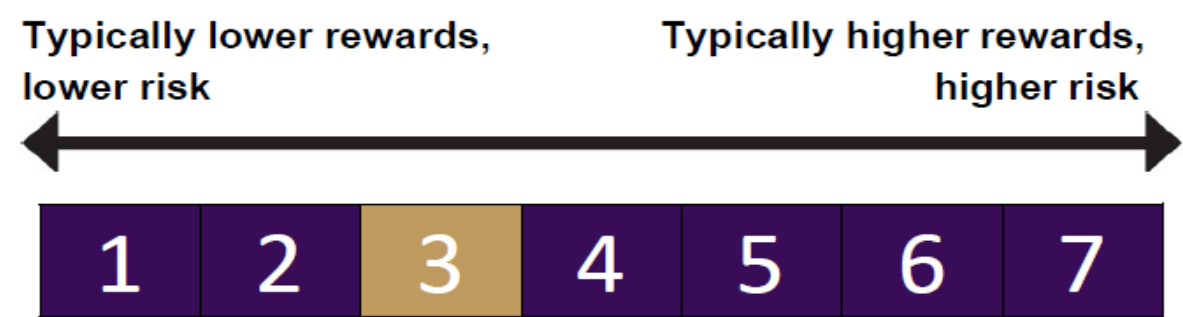
Objectives and Investment Policy

The investment objective of the Fund is to deliver a reasonable level of growth from capital and income over the longer-term. The Fund is a fund of funds so primarily holds investments which include funds, exchange traded funds (ETFs), investment trusts and investment companies. These will be a mixture of holdings that invest in shares of companies and in debt instruments (bonds). On a more limited basis, the investments will be in financial contracts that derive their value from bonds or indices (derivatives) and to a lesser extent, those that invest in shares. They may be established in a broad range of countries and will invest internationally. The Fund may also invest directly in bonds and indirectly in commodities, commercial property and residential property.

The fund may invest in derivatives, financial contracts that derive their value from bonds or indices, these may be used for efficient portfolio management, investment and hedging purposes. The Fund is actively managed, which means that the investment manager takes decisions with the intention of achieving the Fund’s investment objectives and this may include decisions on asset selection, regional allocations, sector views and overall market exposures. The Fund is not managed by reference to a benchmark. All income and gains generated by the Fund will be reinvested. Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The highlighted area in the table below shows the Fund’s ranking on the Risk and Reward Indicator.



The Fund is in this category due to the nature of its investments and previous levels of volatility (how much the value of the Fund rises and falls). Please note that even the lowest risk class can lose you money and that extreme market circumstances can mean you suffer severe losses in all cases. The risk and reward category may shift over time and is not a target or guarantee. The indicator does not take into account the following risks of investing in this Fund:

- Investing overseas can bring additional returns and spread risk to different markets. There are risks, however, that changes in currency exchange rates may cause the value of your investment to decrease or increase.
- Geopolitical and other events may disrupt markets and adversely affect global economies and markets. Those events as well as other changes in foreign and domestic economic and political conditions could adversely affect the value of the Fund’s investments.
- In difficult market conditions, the value of some investments may be less predictable than normal and the Fund may not be able to buy and sell these investments at the best time or at a fair price. This could affect the Fund’s performance, potentially reducing your returns.

- Emerging markets or less developed countries may face more political, economic or structural challenges than developed countries. This means your money is at greater risk.
- Fluctuations in exchange rates can adversely affect the market value of the Fund’s foreign currency holdings and investments denominated in foreign currencies.
- The liquidity of the Fund depends on the liquidity of the underlying funds into which it invests. If underlying funds suspend or defer redemption payments the Fund’s ability to meet its redemption payments could be affected.

The Fund runs the risk that the counterparty to an OTC derivatives contract (i.e. one that is not traded on an exchange) or a borrower of the Fund’s securities will be unable or unwilling to make timely settlement payments or otherwise honour its obligations.

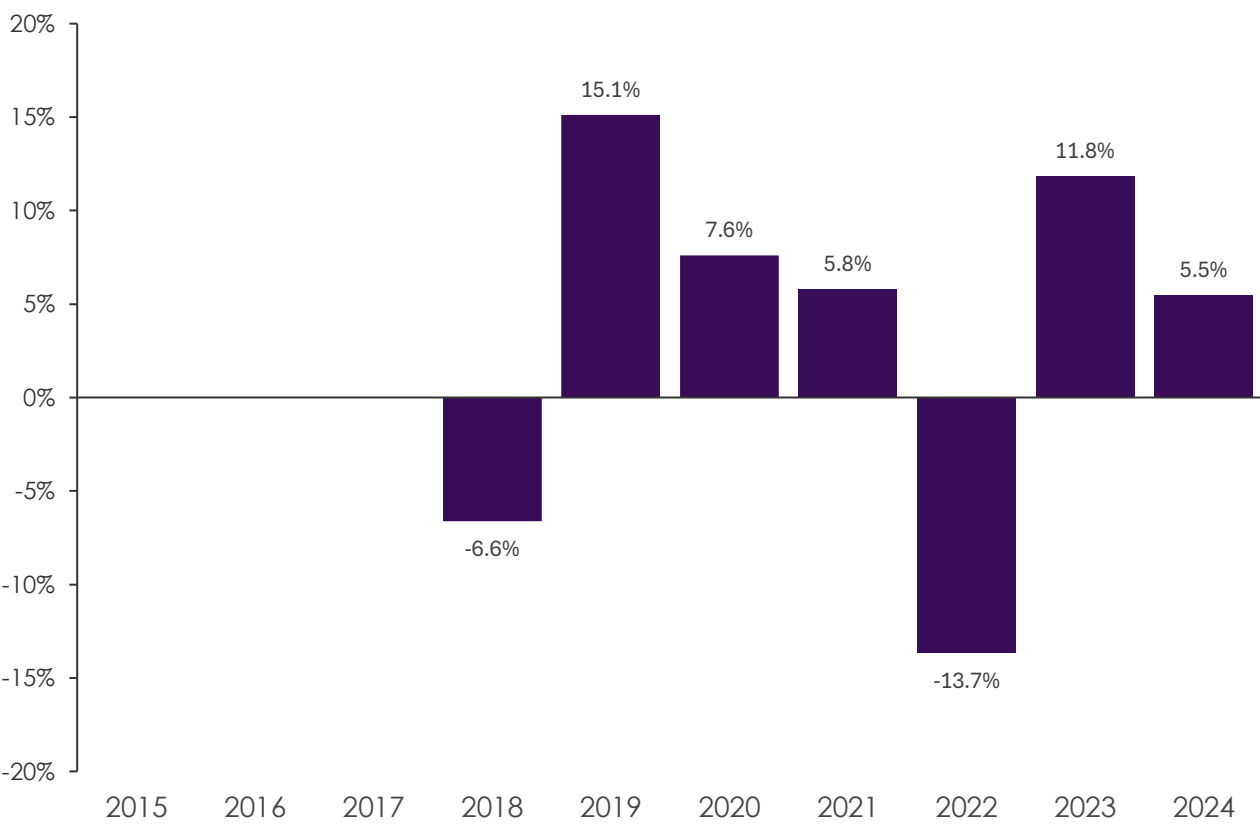

The performance history for the Retail Accumulation USD share class which launched on 25/09/2020 includes the performance of the Retail Accumulation USD Share class of the Original Fund for the period of its launch on 02/07/2016 to 25/09/2020 when it merged into the Fund.

- You may switch your shares in the Fund to shares in another class and/or sub-fund of the ICAV in which you are eligible to invest. Further information in respect of switching is available from the Management Company.
- You can buy, sell or switch shares on any dealing day, being any weekday when banks open in both the UK and Ireland by forwarding a completed subscription or redemption request to the administrator no later than 5.30pm (Irish time) on the relevant dealing day.
