Waystone Management Company (IE) Limited is the UCITS Management Company of the ICAV (the "Management Company").

Objectives and Investment Policy

The investment objective of the Fund is to deliver a reasonable level of capital growth over the long term via significant exposure to equity markets.

The Fund is a fund of funds so primarily holds investments with a focus on global equities. To a lesser extent, the Fund will hold investments which focus on debt instruments (bonds), financial contracts that derive their value from bonds or indices (derivatives). These investments may be established in a broad range of countries and will invest internationally. The Fund may also invest directly in bonds and indirectly in commodities, commercial property and residential property.

The fund may invest in derivatives, financial contracts that derive their value from bonds or indices, these may be used for efficient portfolio management, investment and hedging purposes.

The Fund is actively managed, which means that the investment manager takes decisions with the intention of achieving the Fund's investment objectives and this may include decisions on asset selection, regional allocations, sector views and overall market exposures.


The Fund is not managed by reference to a benchmark.

All income and gains generated by the Fund will be reinvested.

Risk and Reward Profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. The Fund is in this category due to the nature of its investments and previous levels of volatility (how much the value of the Fund rises and falls). 
